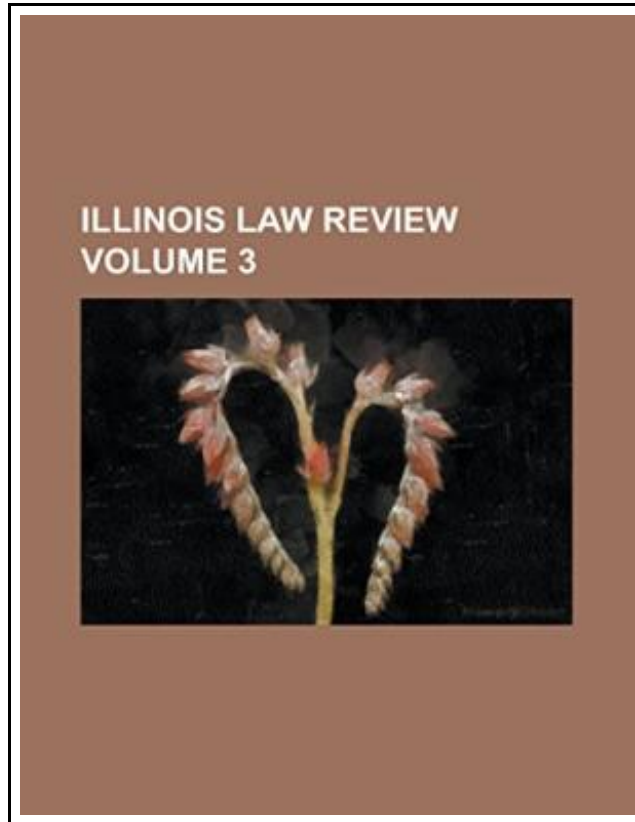

Held, (1) that the refusal of architect s certificate waived tender; (2) that the costs of taking evidence were not called for...
